Previously Renewal of Recognition was granted in "Dayanand Anglo Vedic Public School (EM), Dr.N.T.T.P.S., Ibrahimpattam Village & Mandal, Krishna District" to the Classes I to V (EM) from 2010-2011 to 2019-20 vide Procs.Rc.No.356-A6/09, Dated:-30.11.2009 of the District Educational Officer, Krishna, Machilipattam.

The Principal of the school has submitted the proposals through the Mandal Educational Officer, Ibrahimpattam and requested to accord for Renewal of Recognition to the classes I to V (EM) during the academic years from 2020-2021 to 2029-2030.

The Mandal Educational Officer, Ibrahimpattam has submitted the proposals vide reference 5th cited and recommended to accord the Renewal of Recognition in respect of "Dayanand Anglo Vedic Public School (EM), Dr.N.T.T.P.S., Ibrahimpattam Village & Mandal, Krishna District" for Classes I to V (EM) during the academic years from 2020-2021 to 2029-2030.

After careful examination of the proposals received from the society and also inspection report of the inspecting officer i.e Mandal Educational Officer, Ibrahimpattam, the District Educational Officer, Krishna, Machilipattam who is the competent authority in terms of Rule 3 (1) of G.O.Ms.No.1 Education, Dated.01.01.1994 for Primary Schools/Special Schools hereby accords **Renewal of Recognition** for the classes I to V (EM) during the academic years from 2020-2021 to 2029-2030 in "Dayanand Anglo Vedic Public School (EM), Dr.N.T.T.P.S., Ibrahimpattam Village & Mandal, Krishna District" under the management of **Dayanand Anglo Vedic College Managing Committee, Chitra Gupta Road, Paharganj, New Delhi** without Grant in aid now or in future and subject to fulfillment of the following conditions.

- 1) That the society shall abide by the instructions/rules and regulations made by the Government or authorized officer from time to time. That the Educational Institutions shall serve the needs of the locality more particularly.
- 2) The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
- 3) That the school timing vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
- 4) That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
- 5) That the results of institution shall be satisfactory every year
- 6) That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
- 7) That the list of Governing Body shall be furnished to the District Educational Officer every year.
- 8) That the pay structure/fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
- 9) That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with
- 10) That the school shall not be closed without giving notice both to the parents & competent authority at least 6 months before.
- 11) That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.

- 12) That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
- 13) That the society shall provide fire safety measures in the school as per the No Objection Certificate.
- 14) The management informed that no thatched roof accommodation is allowed to run the School.
- 15) Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students
- 16) Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
- 17) The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
- 18) The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
- 19) The school shall have first aid kit and the teachers shall be trained in first aid.
- 20) The Correspondent of the concerned school is hereby informed to file an affidavit before 30th of April every year to the effect that there is no deviation or volition of norms prescribed by the Government from time to time.
- 21) That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail to the inspecting officer.
- 22) That the management shall ensure the Accounts of the school audited by an authorized Chartered Accountant every year and submit the same to this office along with Annual Administration Report without fail.
- 23) That the management has to maintain trained teachers at all time.
- 24) The management is informed to follow the guidelines issued in G.O.Ms.No.91 Education, Dated.06.08.2009 regarding Fee Structure in Private Schools.
- 25) That the Management is informed to obtain and submit the NOC issued by the Fire Services Dept authorities concerned from time to time without any interruption to the recognition period without fail to the Inspecting officer and also instructed to maintain fire extinguishers sufficiently in the school premises.
- 26) To follow the rules and regulations prescribed in Circular Memo No. 21748/D1/97, Dt: 16.02.1998 and other orders of /Transport authority regarding maintenance of school vehicles/maintenance of vehicles and ensure safety of children, and shall obtain fitness of school vehicles from the transport Authorities as prescribed by the Government from time to time.
- 27) The preventive measures regarding maintenance of school vehicles/maintenance of vehicles to ensure safety of children as instructed in Pr..Rc.No.276/PS-1/2014-2, Dated.19.06.2015 of the C.S.E., AP, Hyderabad should be followed.
- 28) Take requisite steps to enlighten all the teachers in the School about the Prohibition of Corporal Punishment in Schools
- 29) Have adequate personnel to guide the movement of the children to ensure road safety and transportation.
- 30) The Management is informed that the above conditions should be complied from time to time. If the Management fails to comply, the Orders now issued will be reviewed without notice.

To follow the rules and regulations prescribed in Circular Memo No. 21748/D1/97, Dt: 16.02.1998 and other orders of /Transport authority regarding maintenance of school vehicles/maintenance of vehicles and ensure safety of children, and shall obtain fitness of school vehicles from the transport Authorities as prescribed by the Government from time to time.
