Respected Sir/Madam,


With due respect, this is in reference to Point No. 2 mentioned in the rejection letter cited above, regarding the size of classrooms in relation to Clause 4.1 of the CBSE Affiliation Bye-Laws.

In this connection, we respectfully submit the following for your kind consideration:

1. The actual size of the classrooms is 40.46 square metres, which is approximately 435 square feet.
2. We acknowledge and fully understand that, as per CBSE norms, the minimum required classroom size is 500 square feet.
3. The existing school building was constructed several years ago, and at this stage, it is structurally not feasible to modify or expand the existing classrooms.
4. However, the School Project Management planning for the construction of a new school building, strictly in accordance with CBSE norms.
5. The proposed new building will have: Classrooms with an area exceeding 500 square feet, Well-designed laboratories, Library, and Other required infrastructure facilities, all as per CBSE Affiliation Bye-Laws and safety standards.

We humbly request the Board to kindly consider the above submission and allow us an opportunity for review.






